NEW LYMPHEDEMA THERAPY PARTNER

GTH commends The Rehabilitation Institute of St. Louis, a comprehensive rehabilitation facility, for partnering with our program to provide donated lymphedema services for eight patients per year.

The patient receives a glove, compression garments for upper extremities and 6 therapy sessions. This service is so needed because lymphedema is a condition that can occur in breast cancer patients when lymph nodes are removed during surgery or when lymph nodes are affected by radiation therapy. The vessels carrying lymph fluid can become blocked, causing lymph fluid to collect in the arm and/or hand.

Christine Lyss, RN, Gateway to Hope Program Nurse Manager, relates, "lymphedema therapy is not covered by Medicaid and may not be covered by private insurance providers. The condition can be especially debilitating for patients because of the pain and swelling. Often patients are not able to perform their work responsibilities and face further financial hardship. Lymphedema therapy helps to alleviate these symptoms."

Mimi Kramper, LCSW, The Rehabilitation Institute of St. Louis Outpatient Program Manager, said "We are looking forward to our partnership with GTH. We have seen many successes with our lymphedema program. Most of our patients return to a productive lifestyle. We are excited to offer these services to those who may otherwise not have access to this much needed treatment."

Gateway to Hope is exceedingly grateful to The Rehabilitation Institute of St. Louis for contributing to the recovery of our patients whose lives were compromised by lymphedema as a result of their breast cancer treatment.

PATIENT STORY

A WILL TO SURVIVE

Jan is the backbone of her family. She's a strong, self-made insurance agent who loves taking care of her family and her business. True to character, after being diagnosed with breast cancer in December 2012, she refused to believe she couldn't beat it.

Her confidence wavered when she called her insurance company and learned she didn't have enough coverage for even the preliminary tests, much less surgeries, prescriptions and treatments. She was devastated by the thought of financially crippling her husband and family, and soon the financial stress became a heavier burden than the disease itself.

"It was the most helpless time of my life – the first time I had no options, nowhere to turn, no control."



Jan instilled a strong will to survive in her children, and they refused to give up hope for their mother. Their search for a fighting chance led them to Gateway to Hope. The very next day, Jan met with the GTH nurses and a treatment plan was established. She left the office with appointments with her new health care team. Through Gateway to Hope's resources, she bravely underwent a bilateral mastectomy, breast reconstruction, six rounds of chemotherapy, radiation, hysterectomy and ongoing surgeries. Her mantra was always, *"Let's do it! Let's get healthy!"*

Jan is cancer free and back to keeping her family running full speed. Looking back, she says the hardest thing wasn't hearing she had cancer but asking others for help.

"Sometimes you do everything right and you just need help. That's what Gateway to Hope is. They gave me the tools I needed to make me healthy. They saved my life."



HOME CARE ASSISTANCE, A LOYAL PROVIDER AND PARTNER FOR 7 YEARS!

Home Care Assistance (HCA) began their association with Gateway to Hope in 2007. This generous organization has donated 100 hours of care each year for our patients for the last 7 years, establishing HCA as one of our tried-and-true care providing agencies. We are so grateful for the continued support and loyalty of Home Care Assistance's devoted professional staff and caregivers.

Sharon Greenstein, Home Care Assistance's Director of Client Service and Geriatric Care Manager said, "Our caregivers are specifically trained to help patients in transition through HCA's Hospital to Home Program. Patients are often concerned with burdening family members. HCA caregivers relieve patients' anxiety by providing good nutrition, physical activity, mental stimulation, socialization, purpose and calm through our Balance Care system. Nothing works for the patient unless these points are addressed as they recover. Home Care Assistance acknowledges the life-saving work Gateway to Hope provides for breast cancer patients and is proud to be part of their recovery team."

Home Care Assistance provides a full menu of services for patients. Caregivers are trained in the Home Care Assistance Balanced Care system and routinely provide cooking and light housekeeping, laundry and bed linen change, transportation, grocery shopping and errands, bathing assistance, medication reminders and other essential services so our patients can concentrate on their recovery.

Gateway to Hope patients have full lives, lives that include jobs, children, husbands and busy households to run. When our patients are diagnosed with breast cancer, they often tell us that their first thoughts are not about themselves, but how the diagnosis will affect their daily routine, including taking care of their kids and family. According to GTH Program Nurse Manager, Cyndi Stotler, HCA services "are invaluable to our patients. They help them put 'normal' back into daily life. Recovering from breast surgery limits mobility and impedes a woman's ability to complete the normal daily routines of her busy life. Even the simplest of chores become a challenge, reaching for something from a cabinet or doing a load of laundry causes pain. Home Care Assistance workers make the difference. They are there to help maintain the function of a home for our patients and help out in so many ways. They can assist with transportation to and from medical and treatment appointments and can help get kids shuttled around after school. Patients under treatment might be unable to drive, so this service is a huge help. GTH patients tell us that HCA caregivers are kind, caring and compassionate, willing to do anything to make our patients comfortable."

Home Care Assistance has made post-surgery recovery easier for our patients by taking over some of the daily tasks, allowing patients a more worry-free convalescence. Thank you, Home Care Assistance, from the staff, patients and community supporters of Gateway to Hope.

MESSAGE FROM THE PRESIDENT

It doesn't take much attention to be aware of the continual and impactful changes going on in the world of healthcare in general and, specifically, the Affordable Care Act. In addition to the medical concerns our patients have, financial burdens known as "financial toxicity" take a toll as well. Some of our patients have lost employment during treatment and are unable to pay for the necessities of life. At Gateway to Hope, we are concerned with this, and through our Thelma's Gift fund, we are able to pay rent or mortgage, provide gas cards to get to and from treatments, pay utilities to keep the heat on, pay for critical medications, and so much more. Through Thelma's Gift, we can make sure these financial issues do not cause additional stress. The incredible generosity of many of our donors has enabled our patients and families to maintain a level of normalcy while dealing with breast cancer.

Gail's Legacy is another fund at Gateway to Hope that helps alleviate stress for our patients. Many who have come to our Breast Cancer Lifeline had insurance prior to job loss, but lost it during their treatment for breast cancer. Funds available through Gail's Legacy are used to make COBRA payments or insurance premiums for patients to ensure their policies will not be cancelled.
