2014 was an important year for Gateway to Hope. Through the generous support of our donors, partners and providers, we were able to provide assistance for 210 breast cancer patients in the local community. These 210 patients represent 13% of all breast cancer patients in the St. Louis area and a 35% overall increase in the number of patients Gateway to Hope served in 2013. Based on this increase, we anticipate that the need for our services will continue to grow in 2015.
