IN 2020, GTH STAFF HAD OVER 3,000 FORMS OF CONTACT SUPPORTING 358 INDIVIDUALS UNDERGOING TREATMENT FOR BREAST CANCER. AS A RESULT OF GTH'S PROGRAMS AND SUPPORT, GATEWAY TO HOPE PATIENTS ARE 4X LESS LIKELY TO SKIP MEDICATIONS AND APPOINTMENTS. 92% OF INDIVIDUALS SERVED REPORTED BEING BETTER ABLE TO COPE AND BETTER FOCUSED ON THEIR TREATMENT AND HEALTH.
